The *Le Vie dei Tesori Foundation* is a partner of the EU-funded project “Cultural Heritage fOR All: CHORAL”.

The CHORAL project aims to enhance green and digital accessibility to cultural heritage sites in Malta and Palermo. Its goal is to improve access for both tourists and residents by developing a joint strategy and installing orientation totems to promote more sustainable mobility. The project also includes the digitalization of less accessible sites, testing tools in both regions. CHORAL promotes knowledge transfer, creates sustainable frameworks for digitalization, and enhances cultural heritage through broader access and value.

The partnership brings together an interdisciplinary team with diverse skills, capable of effectively delivering project outcomes and achieving significant impact. The project addresses broader issues related to tourist accessibility to cultural heritage sites, identifying gaps in physical access, experimenting with simple, low-cost infrastructures to encourage sustainable tourism, and developing a joint strategy to improve accessibility for all. As part of this process, the project also selects hard-to-reach sites for digitalization, thereby expanding the concept of accessibility and fostering greater tourist engagement with cultural assets and places.

The project duration is 24 months (start date: 02/01/2025 – end date: 02/01/2027).

**SCOPE**

This call for applications is aimed at selecting the following professional role:

**TASKS / RESPONSIBILITIES / ACTIVITIES ENVISIONED FOR THE SELECTED ROLE**

The selected individual will work with the Fondazione Le Vie dei Tesori staff to achieve the objectives associated with the assigned role. The technical specifications of the role and the related remuneration will be detailed during the interview, which will be scheduled following the application process.

**1. ELIGIBILITY REQUIREMENTS**

1. High school diploma or equivalent qualification with at least three years of proven experience relevant to the position;
2. Excellent written and spoken knowledge of the Italian language;
3. Excellent proficiency in major online communication platforms (e.g., Zoom, Google Meet, etc.);
4. Strong organizational skills, time management, teamwork, and problem-solving abilities;

Knowledge of the English language is a preferential qualification;
